PHYSICAL SECURITY

Our physical guarding division offers services ranging from standard stationary security. Our officers are well trained and registered with PSIRA as Security Officers. Our guards were further trained for other critical skills such as Health and Safety, First Aid, Customer Relations, Fire Prevention and are all deployed according to skills and customer requirements.

Security Officers are also monitored directly by Site Inspectors, who visit frequently to ensure presence as well as preventability. Our team of Operation Managers who report to our directors, support this guarding structure within the framework of an ISO managed, quality control programme.

We pride ourselves on transparency and accountability throughout. Our customer relationship programme encourages customers to communicate directly with our management team on an ongoing basis, ensuring a personal, tailored approach to risk management.

Technology is also pivotal to managing our staff and sites, as well as providing transparency and open customer access to performance information. We use the Chase Incident Management platform throughout our operation which provides:

- Real-time incident logging
- System drive security procedures
- Automated reporting on security incidents, as well as feedback
- Incident tracking and case management

Chase also manages and escalates incidents to ensure they are followed up timeously, and full feedback is provided. Comprehensive reporting on statistics based on incident type, location and site and more is used to understand and manage risk in detail.



CLOSE PROTECTION SERVICES (VIP)

Protect and manage the risk exposures of you and your interests with the right VIP close protection officer for the right job, every time. Our team of professionals are always available to ensure your safety. Our Close Protection Service range involves the protection of individuals through Physical Environment Protection, Point-to-Point Safety, and through the services of professionally trained, discreet and creditable bodyguards.



TRAINING

All NPS staff members undergo pre-check and evaluation tests before being taken into the company. Once admitted in the company, they undergo a two-day training that prepares them in areas of operations. Key courses in training are:

- First aid,
- Access control.
- Powers of arrest,
- Searching procedure,

- · Writing of a statement,
- Handling of a crime scene,
- · Risk assessment.

The Crisis Team will convene when the Emergency Coordinator declares a Level 1 Emergency (the most severe category that presents significant risk to our client's reputation and resources).

Given the urgency of rapid communications, the operational manager of NPC Security or his/her designee has the authority to begin taking action immediately, in consultation with the Company Director and the client's security representative.



INVESTIGATIONS

Our investigation department investigates all different types of irregularities that are raised by our clients. Our lead investigator has over 10 years in the field and comes with a wealth of knowledge and experience. All our investigators have a qualification in investigation and affiliated to fraud and investigation companies.

RISK ASSESSMENT AND SECURITY AUDIT

Based on the assessment results, appropriate security protection and safeguards should be implemented to maintain a secure protection framework. This includes developing new security requirements, revising existing security policies and guidelines, assigning security responsibilities and implementing technical security protections.



With implementation of secure framework, there is also the need for constant monitoring and recording so that proper arrangements can be made for tackling a security incident. In addition, day-to-day operations such as users' access attempts and activities while using a resource, or information, need to be properly monitored, audited, and logged.


